Enclosed is an application for pool membership. Please complete both sides of the application, attach a check payable to “**Chestnut Run Pool Association**”, and mail them to:

When completing the application please choose one of the four membership options listed below:

- 1) Family Membership – (Applies to an adult couple with dependants who live at the same mailing address.) Dues are **\$500.00/year**. In addition to the dues, an initiation fee of \$200.00 used toward capital improvements of the pool and the purchase of a Membership Certificate/Bond of \$200.00 are required. The initiation fee and the bond, totaling \$400.00, can be paid over a 4-year period at the rate of \$100.00 each year. After the 4-year period when all monies are paid in full, the Membership Certificate/Bond, valued at \$200.00, is redeemable after resignation from membership.
- 2) Duo Membership – (Applies to an adult couple, without dependents or 1 adult and 1 child who live at the same mailing address.) Dues are **\$400.00/year**. In addition to the dues, an initiation fee of \$200.00 used toward capital improvements of the pool and the purchase of a Membership Certificate/Bond of \$200.00 are required. The initiation fee and the bond, totaling \$400.00, can be paid over a 4-year period at the rate of \$100.00 each year. After the 4-year period when all monies are paid in full, the Membership Certificate/Bond, valued at \$200.00, is redeemable after resignation from membership.
- 3) Single Parent – (Applies to a single parent with dependents who live at the same mailing address.) Dues are **\$400.00/year**. Initiation fee and purchase of bond are the same as detailed above in Family Membership.
- 4) Single/Individual Membership - Dues are **\$300.00/year**. In addition to the dues, an initiation fee of \$100.00 used toward capital improvements of the pool and the purchase of a Membership Certificate/Bond of \$100.00 are required. The initiation fee and the bond, totaling \$200.00, can be paid over a 2-year period at the rate of \$100.00 each year. After the 2-year period when all monies are paid in full, the Membership Certificate/Bond, valued at \$100.00, is redeemable after resignation from membership.
- 5) Senior Citizen Membership - Dues as above in #2 (couple) or #4 (individual), but no membership bond is required.

We are currently offering you a Seasonal Membership. As a Seasonal member you have use of all the pool facilities, but would have no voting privileges in the Association. Once you have paid your initiation fee and bond *in full* you are entitled to voting privileges within the Association. Once your bond is paid in full and you decide to leave the Association, redemption of a bond *must be in writing before the season begins* (May 31st of any given year) and may be directed to the attention of the Financial Secretary. Failure to do so will result in membership dues being deducted from the value of your bond. Should you at any time not wish to renew your seasonal membership before a bond is paid in full, all monies paid toward that bond and initiation fee will be forfeited.

Remember - The Chestnut Run Pool offers free swim lessons to members. We are also the home of the *Chestnut Run Swim Team* that offers opportunities for fun and fitness to members' children.
